## **Radiator VNF Specific License Terms**

These Specific License Terms apply to, and form part of, the Radiator Standard End User License Agreement (“**License Agreement**”).

Section 2 “License Grant” of the License Agreement is amended to read as follows:

### **License Grant**

Subject to the Licensee’s payment of the license fee payable for the license to use the Software, the Licensee is granted a non-exclusive and non-transferable right to use the Software in the Licensee’s own internal operations in the Software’s intended use as specified in the Documentation. The Software is provided to the Licensee only in electronic form for download. Unless otherwise consented to by the Licensor, each Software version or Update (as the case may be) licensed to the Licensee will be made available to the Licensee only once.

The Licensee may install and use the Software on unlimited number of computers, whether those computers are physical or virtual.

The Licensee’s right to use the Software can be limited also by the Licensor’s pricing terms, which can for example set certain limits to capacity, number of transactions, other means of use or volumes.

The Licensee is required to provide to the Licensor or the Licensor’s distribution partner or reseller each month the activity report regarding the usage of the Software that is produced automatically by the Software’s reporting tool or produced by the Licensee by using the Software’s reporting tool manually (“**Radiator Activity Report**”). Alternatively the Licensor, the Licensor’s distribution partner or reseller and the Licensee can jointly agree on a reporting and report delivery model which ensures that the Licensor is provided with at least the same information as in the Radiator Activity Report on time intervals jointly agreed.

The Licensee may make one (1) back-up copy of the Software solely for back-up purposes, provided that the Licensee affixes to such copies all copyright and proprietary notices that appear on the original copy.

The Software may only be installed and operated on computers that are owned by or leased to the Licensee or its Operating Partner. The Licensee shall ensure that the Operating Partner runs and operates the Software only on behalf of the Licensee and only for the benefit of the Licensee. The Licensee shall be liable for the actions of the Operating Partner.

The Licensee and the Licensee’s Operating Partner may use the Documentation internally in order to support the above-mentioned licensed use of the Software only on behalf of and for the benefit of the Licensee.

In other respects, the terms and conditions of the License Agreement remain unchanged.
